2. Reservation will be as per Government of India guidelines issued from time to time. Assignment of Reservation Category to each post has been done as per DOPT Reservation Roster. However, the competent authority reserves the right to amend the reserved posts as per administrative requirements.

4. All Candidates must have up-dated Medical Registration (NMC / State Medical Council) with all post MBBS/MD/MS Qualification(s)). In case, candidate(s) do not have up-dated registration from Medical Council, they have to show and submit copy of "Applied for document(s)" to concerned authority at the time of interview. In case, these two clauses are not fulfilled, the candidate either may not be interviewed or their results will remain with-held in case the expert committee allows them to appear at the interview. 6. No private practice is allowed in any capacity after joining as teaching faculty at ESIC Medical College & Hospital, Ranchi (Jharkhand).
7. **Reservation of Person with Benchmark Disability (PWD) is as per prevailing guidelines of Government of India. In case candidates in these categories are not available, then the vacancies will be filled from the panel of candidates who attend the interview in view of essential services of the Medical College and for fulfillment of NMC Norms and reservation of PWD shall be carry forwarded.**

(01) Eligibility Criteria:

1. Age Limit as on Date of Interview: Not exceeding 69 years (except Senior Resident), age relaxation as per the prevailing norms of government of India (GOI).
2. Age Limit as on Date of Interview: Not Exceeding 45 Years (For Senior Resident)

Note:

1. The maximum tenure of such engagement will be till 70 years of age for teaching faculty whichever is earlier provided other rules & regulations are satisfied.
2. The EWS Candidates should submit EWS Certificate as per Annexure-I of Govt. of India, Ministry of Personnel, Public Grievances & Pensions, DOPT Office Memorandum No. 36039/1/2019-Estt (Res), dated 31.01.2019.
3. The OBC (Non-Creamy Layer) Certificate should be issued and not prior to 01 (One) Year from the date of interview. It has to be as per the format applicable for job in Govt. of India and to be issued by an Officer not below the rank of Sub-Divisional Officer or Equivalent Authority of the concerned State for Central Govt. job.
4. Reservation for Person with Disability (Divyangjan) Candidate will be maintained as per Government of India (GoI) norms.

(02) Educational Qualifications: As per National Medical Commission (NMC erstwhile MCI) guidelines.

(03) Pay and Allowances:

- a) Professor: Level 13 of 7th CPC (Total Consolidated Pay of Rs. 256140/-) and as per amendments from ESIC Hqrs.
- b) Associate Professor: Level 12 of 7th CPC (Total Consolidated Pay of Rs. 165945/-) and as per amendments from ESIC Hqrs.
- c) Assistant Professor: Level 11 of 7th CPC (Total Consolidated Pay of Rs. 143345/-) and as per amendments from ESIC Hqrs.
- d) Senior Residents: Level 11 of 7th CPC (Fixed Basic Pay of Rs. 143345/-) and as per amendments from ESIC Hqrs.

In case of engagement of retire employees/ pensioners, they may be allowed to draw total pay without any deduction as it is not a case of re-employment in terms of Central Civil Services (Fixation of Pay of Re-employed Pensioner) Orders 1986 and retired employees/ pensioners can continue to draw pension and dearness relief on pension during their period of contractual engagement.

(04) Terms of Contract:

- (i) The tenure of all above post(s) will be for 01 (One) year OR attainment of 70 years of age; whichever is earlier.
- (ii) The contractual engagement may be terminated/ discontinued from either side giving one-month prior notice to this effect without assigning reason. In case of spot resignation by the selected candidate, one month's salary is to be deposited to ESI Account through Challan.
- (iii) No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance, Medical Benefits, Seniority, Promotion etc. will be admissible.
- (iv) This, being a contractual appointment, absence from work for a period beyond the 07 (Seven) days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The teaching faculty is required to mark attendance manually as well as on Aadhaar Enabled Biometric Attendance System (AEBAS) daily during scheduled working days.

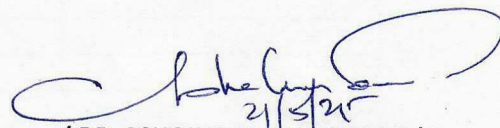

(07) Selection Procedure:

- (i) The Selection will be made on the basis of acquired academic credentials and performance of candidate in interview before the Selection Board.
- (ii) Result will be displayed in Recruitments section of Website: www.esic.gov.in.
- (iii) Offer of Appointment will be sent through E-mail only.
- (iv) Selected candidates will have to join as per instructions mentioned in offer of appointment.

(08) Important Note:
